



FACT SHEET: EQT TAX AWARE AUSTRALIAN EQUITY FUND (WHOLESALE CLASS)

About the Fund

The EQT Tax Aware Australian Equity Fund offers a diverse portfolio comprising of high-quality companies that are currently included in, or suitable for inclusion in the ASX 200 index. The companies are selected through Equity Trustees' proprietary **Quality At a Reasonable Price (QARP)** investment process which identifies quality companies with an attractive industry structure, strong balance sheets, robust return on equity, substantial cashflows and good management.

We believe quality companies will outperform over the longer term and a portfolio of quality stocks will provide some downside protection when the market falls.

Investment objective

The Fund is designed for investors seeking strong medium-long term capital growth potential, coupled with an increasing income stream payable from the dividends of the underlying shares. There is a distinct focus on the after-tax returns offered to investors.

The Fund aims to outperform its Benchmark over a rolling 3-year period, after taking into account Fund fees and expenses.

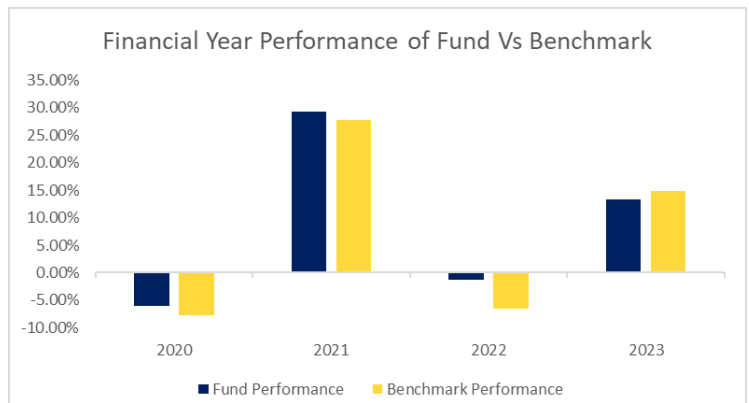

Performance illustrates our Process – Downside Protection

The chart below shows that in times when the market rises the Fund performs broadly in-line but outperforms when the market falls. The FY returns are for the Retail Unit Class of the EQT Tax Aware Australian Equity Fund, same strategy as the Wholesale Class.

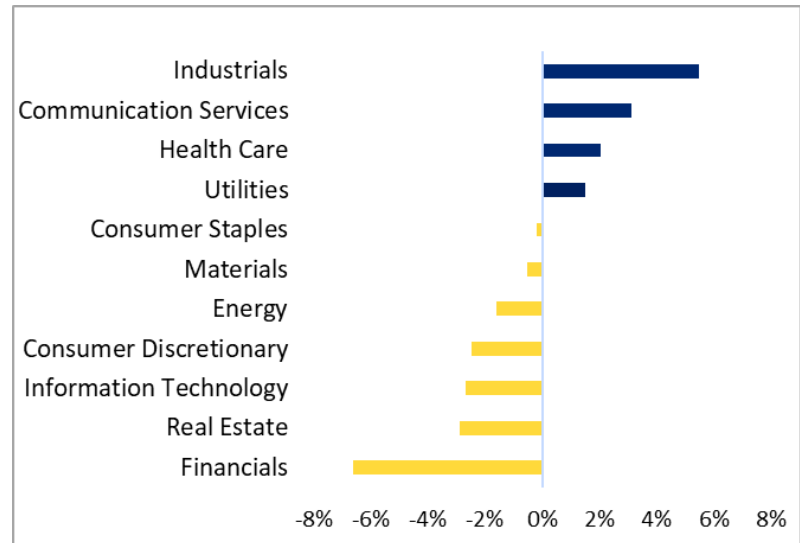
