## Proposed change of Responsible Entity for the Impax Sustainable Leaders Fund

Equity Trustees Limited ABN 46 004 031 298 AFSL 240975 ("we", "Equity Trustees"), as responsible entity for the Impax Sustainable Leaders Fund ARSN 615 479 662 ("Fund") is calling a meeting of members to consider an extraordinary resolution to replace Equity Trustees as responsible entity of the Impax Sustainable Leaders Fund with Fidante Partners Limited ABN 94 002 835 592 AFSL 234668 ("Fidante").

We propose to retire as responsible entity of the Impax Sustainable Leaders Fund and Fidante has agreed to be appointed in our place provided that the members of the Impax Sustainable Leaders Fund pass the resolution required to effect this change. We note that Fidante has agreed to pay the costs of convening and holding the meeting.
