## APPLICATION GUIDELINES

## HOW GRANTING DECISIONS ARE MADE

Members of the committee evaluate grant applications according to the intentions of the Foundation's founder, Leonard Holmes Angior, that is:

- The Anglican Church of Australia Trust Corporation for the Diocese of Melbourne,
- Charities having, as their main purpose, the support of performing arts in Victoria, and
- Charities engaged in the provision of medical services or in medical research of any description.

Advisory committee members consider annual applications for funding up to \$30,000 from February to the end of March via SmartyGrants.

## ELIGIBILITY

The Foundation can only consider requests from organisations that:

- Are based in Victoria, or who will use the grant primarily for the benefit of Victorians
- Have an Australian Business Number (ABN)
- Are registered with the Australian Charities and Not-for-profits Commission (ACNC), and
- Are a Deductible Gift Recipient level 1 (DGR1).

## GRANT EXCLUSIONS

The Foundation does not make grants for the following purposes:

- To or on behalf of individuals
- Capital fund-raising for major building purchase, construction, and maintenance works
- General fundraising appeals
- Motor vehicles and buses
- Sport, recreation, or social activities for their own sake
- Scholarships and bursaries
- Arts projects for art's sake - however, the Foundation will consider arts initiatives that support public education or that facilitate the improvement of social outcomes
- Provision of health and medical services already provided by Public Agencies
- Protection and welfare of domestic animals.



## APPLICATION TIMELINE

The funding round is based on the calendar year.

The following table provides timelines for the application process:

ACTION	DATE
Application open	Monday 5 February 2024
Application closed	Friday 22 March 2024
Applications advised of outcome	Friday 7 June 2024

## GRANTING PROCESS

Funding decisions are made in line with the Foundation's granting process.

A process outline is detailed below:

**Step 1:** Applicant reviews the granting guidelines and funding criteria to self-assess eligibility (see Granting Guidelines).

**Step 2:** Applicant completes the online application form by due date (Friday 22 March 2024), noting that no more than one application is to be submitted in total by any one organisation.

**Step 3:** Advisory committee meets to review grant applications in May 2024 and make recommendations to the trustee.

**Step 4:** Trustee advises applicants of outcome. Successful applicants receive grants in mid-late June 2024.

**Step 5:** Progress report and / or acquittals will be requested by the Trustee approximately 12 – 15 months after grant payment.
